SUBJECT: ALFOODACT 2017-039 - New England Natural Bakers Issues Voluntary Recall - Listeria

Date Issued: 16 June 2017

1. REFERENCES:

a. DLAR 4155.26/AR 40-660/NAVSUPINST 10110.8c/AFI 48-116/MCO 10110.38c, DOD Hazardous Food & Nonprescription Drug Recall System.

2. Background: NEW ENGLAND NATURAL BAKERS of Greenfield MA, is issuing a voluntary recall, the company has been notified by an ingredient supplier that an ingredient used in these products has the potential to be contaminated with Listeria monocytogenes.

Listeria monocytogenes is an organism, which can cause serious and sometimes fatal infections in young children, frail or elderly people, and others with weakened immune systems. Healthy individuals may suffer only short-term symptoms such as high fever, severe headaches, stiffness, nausea, abdominal pain and diarrhea. Listeria infection can cause miscarriages and stillbirths among pregnant women.

No illnesses have been reported in relation to this product at this time.

The potential for contamination was noted after an ingredient supplier revealed the possible presence of Listeria monocytogenes.

We take food safety seriously and sincerely apologize for any inconvenience this may have caused. Consumers should discontinue use of the product listed above and may return the product to the retail establishment it was purchased at for a refund.

Home-ported ships/galleys will utilize DD form 1149 to transfer with reimbursement to the PV. The PV will submit credit invoice to the account manager at DLA Troop Support.

d. AAFES, MWR, NEX, MCCS, DeCA, dining facilities, and all other agencies, report your findings in accordance with the procedures outlined by your agency.
