2. Background: Several assorted sized packages of Philadelphia Cream Cheese have been found to have holes poked in the product packaging.

3. Product Affected: All Philadelphia Cream Cheese products. All lots, all UPCs, all sizes, all flavors should be inspected prior to use/sale. Product with holes should be isolated and placed on medical hold. Please contact your supplier for additional/disposition instructions.

Your supporting NAVSUP FLC should forward to the account manager at DLA Troop Support. The form should include the number of the recall authorizing the survey action. Home-ported ships/galleys will utilize DD form 1149 to transfer with reimbursement to the PV. The PV will submit credit invoice to the account manager at DLA Troop Support.

d. AAFES, MWR, NEX, MCCS, DeCA, DLA, dining facilities, and <u>all other agencies</u>, report your findings in accordance with the procedures outlined by your agency.
