SUBJECT: ALFOODACT 2017-051 — Philadelphia Cream Cheese suspected tampering is isolated to specific products

- 1. REFERENCES:
- a. DLAR 4155.26/AR 40-660/NAVSUPINST 10110.8c/AFI 48-116/MCO 10110.38c, DOD Hazardous Food & Nonprescription Drug Recall System.
- 2. Background: After conducting an internal investigation, the Kraft Heinz Company is confident that the suspected tampering (holes poked in packaging) is limited to the Philadelphia Soft Cream Cheese <u>tubs</u> from a specific production facility (details below). All other Philadelphia Cream Cheese products are **not affected**. Please see product listing and photos below.
- 3. Product Affected: The only affected product is the Kraft Philadelphia Soft Cream Cheese Tubs from a production facility designated with the code "B8" at the bottom of each tub.

The product code markings on the bottom of each tub are deciphered as follows:

03 FEB 2018 (DD MMM YYYY = day month and year for expiration date) B 23:36**B8** (L HH:MM FL = lane ID, time stamp, and factory/line ID)

Product with a "B8" on the bottom of the tub should be evaluated for any evidence of holes on the foil liner. If small holes are observed, the product should not be used, should be isolated and placed on medical hold.

- d. AAFES, MWR, NEX, MCCS, DeCA, DLA, dining facilities, and <u>all other agencies</u>, report your findings in accordance with the procedures outlined by your agency.
