SUBJECT: ALFOODACT 2018-003 – Ventura Foods Recalls Sun glow Butter Blend - Soy

Date Issued: 9 January 2018

1. REFERENCES:

a. DLAR 4155.26/AR 40-660/NAVSUPINST 10110.8c/AFI 48-116/MCO 10110.38c, DOD Hazardous Food & Nonprescription Drug Recall System.

2. Background: A recall has been issued on the following Sun glow European Style Butter Blend (ESBB) products due to it containing undeclared allergen (Soy Lecithin). The trace amounts of soy lecithin contained in the product is not likely to cause adverse health consequences. However, people who have an allergy or severe sensitivity to soy run the risk of severe or life-threatening allergic reaction if they consume this product.

No illnesses related to this product have been reported.

Please place the product on medical hold and contact your product distributor or supplier for final disposition instructions.

3. Product Affected: The affected lot numbers are located on the cardboard shipping case and can be found embossed on the inner parchment wrap on Sun glow Unsalted ESBB (16953 SNG) and Sun glow ESBB (16842 SNG).





Home-ported ships/galleys will utilize DD form 1149 to transfer with reimbursement to the PV. The PV will submit credit invoice to the account manager at DLA Troop Support.

d. AAFES, MWR, NEX, MCCS, DeCA, DLA, dining facilities, and **all other agencies**, report your findings in accordance with the procedures outlined by your agency.
