SUBJECT: ALFOODACT 2018-060 - Bob Evans Farms Inc. Recalls Pork Sausage Link Products Due to Possible Foreign Matter Contamination

Date Issued: 14 September 2018

1. REFERENCES:

a. DLAR 4155.26/AR 40-660/NAVSUPINST 10110.8c/AFI 48-116/MCO 10110.38c, DOD Hazardous Food & Nonprescription Drug Recall System.

2. Background: Bob Evans Farms, Inc., a Xenia, Ohio, establishment, is recalling approximately 46,734 pounds of pork sausage link products that may be contaminated with extraneous materials, specifically pieces of clear hard plastic.

The products subject to recall bear establishment number "EST 6785." These items were shipped to retail locations in IN, IL, MD, MI, MO, NJ, NY, NC, OH, PA, VA, and WI.

The problem was discovered when the establishment received consumer complaints of extraneous material in the pork sausage products.

There have been no confirmed reports of adverse reactions due to consumption of these products. Anyone concerned about an injury or illness should contact a healthcare provider.

FSIS is concerned that some product may be frozen and in consumers' freezers. Consumers who have purchased these products are urged not to consume them. These products should be thrown away or returned to the place of purchase.

FSIS routinely conducts recall effectiveness checks to verify recalling firms notify their customers of the recall and that steps are taken to make certain that the product is no longer available to consumers.
