SUBJECT: ALFOODACT 2018-066 - Update to ALFOODACT 2018-065 – Advance Pierre Foods, Inc. (Tyson Foods, Inc.) Recalls Frozen/RTE Sandwiches Due to *Salmonella* or *Listeria monocytogenes*

2. Background: Advance Pierre Foods, Inc. (Tyson Foods, Inc.) of Claremont, NC has been made aware that one of their suppliers, McCain Foods USA, Inc. is conducting a voluntary recall involving onions, peppers and other fire-roasted vegetables due to the potential contamination with *Listeria monocytogenes* or *Salmonella spp.* As a result of this recall Advance Pierre Foods, Inc. (Tyson Foods, Inc.) is recalling product containing the potentially contaminated vegetables out of an abundance of caution.

Salmonella and *Listeria monocytogenes* are organism that can cause serious and sometimes fatal infections especially in young children, the elderly, and in individuals with weakened immune systems. *Salmonella* infections in healthy people can cause fever, diarrhea (sometimes bloody), nausea, vomiting and abdominal pain. In rare circumstances with *Salmonella* infections, the organism can potentially get into the bloodstream and cause a more severe illnesses such as inflammation in the arteries, heart and joints. *Listeria* infections in healthy people may possibly result in only short-term symptoms such as a high fever, a severe headache, stiffness, nausea, abdominal pain and diarrhea. The *listeria* organism can cause miscarriages and stillbirths among pregnant women.

The affected product was ordered and shipped as Steak-Eze Philly Cheese Steak Sandwiches, Pierre Philly Style Cheese Steak Sandwiches, and Pierre Philly Style Chicken Sandwiches. No other Tyson products are affected by this voluntary recall at this time.

This product being recalled should not be consumed. This recall is being made with the knowledge of the Food & Drug Administration.
