SUBJECT: ALFOODACT 2019-020 – EXPANSION to ALFOOACT 2019-014 - Tyson Foods, Inc. Recalls Chicken Strip Products due to Possible Foreign Matter Contamination

Date Issued: 04 May 2019

Updates are highlighted in red below.

1. REFERENCES:

a. DHA-MSR 6025.01/AR 40-660/ DLAR 6025.01/NAVSUPINST 10110.8D/AFI 48-161\_IP/MCO 10110.38D, DOD Hazardous Food & Nonprescription Drug Recall System, 6 September 2018.

2. Background: Tyson Foods, Inc., a Rogers, Ark. establishment, is recalling approximately 69,093 pounds of frozen, ready-to-eat chicken strip products that may be contaminated with extraneous materials, specifically pieces of metal, the U.S. Department of Agriculture's Food Safety and Inspection Service (FSIS) announced. **Tyson Foods, Inc., a Rogers, Ark. establishment, is recalling approximately 11,829,517 million pounds of frozen, ready-to-eat chicken strip products.**

The problem was discovered when FSIS received two consumer complaints of extraneous material in the chicken strip products.

These items were shipped to retail locations nationwide and for institutional use in locations in Michigan and Washington.

There have been no confirmed reports of adverse reactions due to consumption of these products. Anyone concerned about an injury or illness should contact a healthcare provider.

FSIS is concerned that some product may be in consumers' freezers. Consumers who have purchased these products are urged not to consume them. These products should be thrown away or returned to the place of purchase.
