BACKGROUND: Hormel Foods Sales LLC is voluntarily recalling 15,352 cases, or 187,755 total pounds, of a single code date of SKIPPY® Super Chunk Peanut Butter due to the possibility that some jars may contain slightly elevated aflatoxin levels.

Aflatoxins are notorious for the many health consequences that occur from consumption of aflatoxin-contaminated food, including aflatoxicosis and liver damage. Aflatoxins are a known carcinogen and their presence in food should be restricted to the lowest practical level.

This recall relates only to 16.3-ounce jars of SKIPPY® Super Chunk Peanut Butter with the specific code date indicated above. No other SKIPPY® or HORMEL products are affected.

No illnesses or injuries have been reported in association with this recall.

This recall is being carried out to the retail level but is a product that is distributed to military customers at the prime vendor level.

This recall is being made with the knowledge of the U.S. Food and Drug Administration.
