

- I. All terms and conditions of the subject contract remain the same except for the following:
 - 1. After current supplies of turkey nuggets are depleted for assembly into the Meal, Ready-to-Eat (MRE), Beef Strips (8940-01-429-7067, A-A-20298B, Variety A, Type II, Style a, Class 1, Flavor (a)) may be substituted for Turkey Nuggets (8940-01-578-8901, A-A-20298B, Variety B, Type III, Style b, Class 4, Flavor (a)) to complete MRE-33 assembly. The recommended substitution will not have a negative impact on the nutritional content of the menus.
 - 2. For Commercial Item Description A-A-20298B, dated 7 July 2009, in paragraph 6.3, Analytical and Microbiological testing, for Aerobic Plate Count, add the following Official Methods of Analysis of the AOAC:
 - 990.12 (Aerobic Plate Count in Foods, Dry Rehydratable Film Method)
 - 2008.10 (Enumeration of Aerobic Mesophilic Flora in Foods)

II. If the contractor incurs increased or decreased costs as a result of this modification the changed costs must be submitted to the ACO within 30 days. If nothing is submitted within 30 days, this modification will be considered finalized at no increased or decreased cost to the Government or the contractor. This does not waive any right of the ACO to review this mod and proceed with a formal finalization of this modification.
