

I. All terms and conditions of the subject contract shall remain the same except for the following:

Elbow Macaroni In Tomato Sauce, Packaged In a Flexible Pouch, Shelf Stable, shall be made in accordance with PCR-E-019, with Change 1, dated 18 December, 2015. This change removes the dietary fiber requirement from PCR-E-019. This change does not remove the whole grain requirement. The removal of the dietary fiber requirement will promote a more consistent high quality end item product.

Current inventory of barrier film may be used up before implementation of this change, but DLA Troop Support is to be informed of the estimated changeover date.
