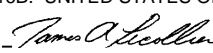

I. "The following notes provide clarification applicable to Table II of MIL-PRF-44073:

Note 1/ When determining compliance with seal width dimensions as specified by Figures 1, 1A, 4, and 5, other than those dimensions cited as or depicted as "Notch Details" and "Bottom Seal", apply a tolerance of + 1/16 inch to the dimensions depicted in the figures.

Note 2/ Use the seal width dimensions described for conventional heat seals in paragraph 3.1.4.1 as the seal width dimensions required for Horizontal, Form-Fill-Seal pouches.

Note 3/ Applicable to heat seals other than closure seals: Any heat seal width less than 1/16 inch at any location along its continuous path shall be recorded as a Critical category defect. Continuous path includes the location between the tear notch and the food product edge of the heat seal.

Note 4/ Applicable to heat seals other than closure seals: Any heat seal width less than 1/8 inch but greater than or equal to 1/16 inch at any location along its continuous path shall be recorded as a Major B category defect. Except for Horizontal, Form-Fill-Seal pouches, Continuous path includes the location between the tear notch and the food product edge of the heat seal.

Note 5/ Until further notice, "Note 2/" and "Note 4/" do not apply to the Horizontal, Form-Fill-Seal pouch heat seal width measured along the shortest distance between the tear notch and the food product edge of the heat seal."

II. The following applies to PCR-G-003, Granola, Packaged in a Flexible Pouch, Shelf Stable:

A. Page 12, Section E-5, Paragraph B(3), under column for Fat Test Method Number, delete "985.15" insert "945.38, 960.39, 2008.06".
