

The following changes apply to PCR-C-041, Cocoa Beverage Powder, Fortified:

Page 2, paragraph C-2,G,(4). Delete "(4) Vitamin A. The Vitamin A content shall be not less than 752 retinol equivalents per pouch."

Page 3, paragraph C-2,I,(6). Delete "Vitamin A shall be the dry, water-dispersible vitamin A palmitate, stabilized in gelatin, gums, or other edible materials with or without sugar. One hundred percent of the stabilized vitamin A palmitate shall pass through a U.S. Standard No. 20 sieve, and not less than 90 percent shall pass through a U.S. Standard No. 30 sieve."

Page 12, paragraph E-5,B,(3). Line 3, delete "Vitamin A" and delete "15.15 1/ 2/"

Page 12, paragraph E-5,B,(3). Line 4, delete "or Thiamin" and delete "3/"

Page 12, paragraph E-5,B,(3). Line 5, delete "Pyrodoxine" and delete "3/". Add "2004.07" after "985.32 or".

Page 12, paragraph E-5,B,(3). Line 6 and 7, delete "and RE for Vitamin A".

Page 12, paragraph E-5,B,(3), Footnote 1/. Line 1, delete "Vitamins A, B1, B6, and C" and replace with "Vitamins B1 and B6".

Page 12, paragraph E-5,B,(3), Footnote 2/. Delete footnote 2/.

Page 12, paragraph E-5,B,(3), Footnote 3/. Delete footnote 3/.
