The preceding instruction, discontinuing the heating of product examination sample pouches,

shall also apply to subsequent editions or revisions of PKG&QAP A-A-20352 applied to this contract.

Instructions for preparing pouches for the drained weight inspection by immersing pouches in not less than 140°F and not greater than 190°F water for 10 minutes prior to conducting the drained weight inspection shall remain as designated in E-5, A, of the PKG&QAP.

- It is recommended that the set of sample pouches used to conduct the drained weight inspection also be used to determine the net weights of pouches, each successive sample pouch to have both a net weight and a drained weight determination performed on and recorded for that sample pouch."

The submitted DLA Troop Support Form 2651 or other report must be executed by the Government representative or the document will not be considered valid and therefore will not relieve the contractor of this requirement or of its liability for any assembly shutdown. In addition, nonconformances detected in GFM must be reported to the PCO on a daily basis.
