"Orders will be placed with no less than a 60 day lead-time, and must be placed in economic production quantities, unless the component contractor concurs and there is no additional cost. The required delivery date will be established with the issuance of the delivery order. Failure to deliver the required quantities by the date set forth by the assembler may result in termination of the contract by default."
