<p>The purpose of this Modification is to update Technical Specifications as stated below:</p> <p>I. The following is applicable to contract SPE3S1-22-D-Z149:</p> <p>A. The purpose of this Modification is to update the pouch code labeling requirement for individual operational rations component packages that require the lot number in the pouch code to represent the date of pack expressed as a four-digit Julian code. Until further notice, the date of pack representing the lot number in the pouch code for individual rations component packages shall be as follows:</p> <p>"Each pouch shall have the date of pack noted by using either a four-digit code or five-digit code. When using the four-digit code, begin with the final digit of the current year followed by the three-digit Julian code. For example, 14 February 2050 would be coded as 0045. When using the five-digit code, begin with the decade digit of the current year followed by the three-digit Julian code. For example, 14 February 2050 would be coded as 50045. The Julian code shall represent the day the product was packaged into the pouch."</p> <p>II. All other terms and conditions remain the same.</p>
