The purpose of this amendment is to provide notice of the following changes to Solicitation SPE3S126R0006:

1. DELETE the following paragraph in Section B-4 in its entirety:

"The Guaranteed Minimum (GM) Dollar Value for the RNC Wet Pack Fruit is anticipated to be \$7,599,501.17 based on multiplying the average unit price over five (5) tiers for each item with the guaranteed minimum quantity per item. The sum of each item's guaranteed minimum dollar value is taken to determine the total guaranteed minimum dollar value. As the final lowest award price may end up higher or lower, the guaranteed minimum dollar value cited above is only an estimate for planning purposes. The final GM amount will be established at time of award when final pricing is known, using the above methodology."

2. REPLACE WITH the following paragraph:

"The Government guarantees that it will order the minimum of units stated above in Section A. Indefinite-Quantity Contract (IQC) Quantities during the life of the resultant contract(s). The guaranteed minimum quantity may be ordered during any tier period or combination of tier periods. The Government may fulfill the guaranteed minimum quantity by issuing a single delivery order or any number of delivery orders. Any quantities ordered by the Assemblers shall contribute towards satisfying the Government's guaranteed minimum quantity. However, in fulfilling the guaranteed minimum quantity, the total dollar value expended by the Government shall not exceed the dollar value of the guaranteed minimum quantity procured at the lowest unit price established under the contract(s) and is hereafter referred to as the "guaranteed minimum dollar value." If an offeror is awarded multiple line items, then the total guaranteed minimum dollar value for the contract(s) shall be the sum of each awarded line item's guaranteed minimum dollar value. The Government will be considered to have fulfilled its obligation to order the guaranteed minimum quantity when the guaranteed minimum dollar value has been met."
