E-3-B-1 For thermostabilized, high-pressure processed, and hot-filled items procured as contractor furnished material (CFM) components, when the manufacturer/packager is the prime contractor (assembler), or a subcontractor, origin inspection shall be **IN HOUSE** contractor paid United States Department of Agriculture, Agricultural Marketing Service, Specialty Crops Program, Specialty Crops Inspection Division, Contract Services Branch (USDA,AMS,SCP) inspection in accordance with provision "9023 General Inspection Requirements" unless otherwise specified by this solicitation/contract. The regulations, file codes, etc. of the respective agency are applicable to the contract in conjunction with the quality assurance requirements of the contract. Optional contractor testing provided by provision "9024 Alternative Inspection Requirements for Selected Items" is applicable, unless otherwise specified by this solicitation/contract. When permitted by the applicable food component specification, a Certificate of Conformance (COC) for ingredients shall be provided in accordance with FAR Clause 52.246-15.

5. Solicitation closing date is extended to April 19, 2019 at 3:00 P.M. Eastern time.
