The purpose of this Amendment is to incorporate the following changes:

A. Page 6, Table II., Beverage Bases (Powdered), A-A-20098F, Type III, Design D, line after "Raspberry, Non-Fortified Flavor 13, Formulation a", insert "Cranberry Grape, Not Fortified Flavor 22, Formulation a".

B. Clarifications:

For Chicken Chunks, the residual gas level for the three year shelf life thermally processed items packaged in accordance with MIL-PRF-44073, other than the wet pack fruits, is 20 cc. A gusseted pouch is an option, not a requirement.

MIL-PRF-44073; "3.1.4.2 Residual gas volume. Residual gas volume in filled and sealed SSP pouches shall not exceed 20 cubic centimeters (cc), except pouches with five ounces of fruit shall not exceed 10 cc."

All other Terms and Conditions of the solicitation remain the same.
