OPERATIONAL RATIONS INSPECTION PROCEDURE (OPRATS IP11) 1 March 2013

First Strike Ration (FSR) Procurement/Origin/In-Plant Verification Inspection

- 1.0 <u>PURPOSE</u>: To establish standardized procedures for the FSR and other individual operational rations procurement/origin/in-plant food safety and quality assurance functions.
- 2.0 <u>SCOPE</u>: This procedure applies to current and future Army Veterinary Inspectors (AVIs) that are assigned to, are on assignment orders to, and on TDY status at any of the three MRE Ration Assembly Plants (Evansville, Mullins, and Cincinnati).
