I. The purpose of this modification is to incorporate the following updated specification into Contract SPE3S1-14-D-Z100:

I. Solicitation, Page 52, 5. MARKING: A.1., delete first sentence in entirety and insert: "Commercial marking of shipping containers is acceptable, although shipping containers shall be marked in accordance with section D.2. of DLA Troop Support Form 3556, except for Line 7 - Inspection/Test/Date. The Inspection Test Date shall not be included on the shipping containers. The NOTE still applies.

All other terms and conditions remain the same.
