The following change applies to Solicitation SPE3S1-14-Q-0006 / Contract SPE3S114DZ104:

I. Page 22 of 57, Compliance With Applicable Regulations, delete first paragraph and insert "The Contractor shall comply with 21 CFR §110 "Current Good Manufacturing Practice in Manufacturing, Packaging, or Holding Human Food" or 21 CFR §117 "Current Good Manufacturing Practice, Hazard Analysis, and Risk-Based Preventive Controls for Human Food", and other applicable regulations. The Contractor shall ensure all sub-contractors comply with all applicable regulations. In addition, the contractor is required to comply with all applicable parts of the Code of Federal Regulations."

II. Page 27 of 57, delete the following text: "In addition, each unit load shall be provided with a Material Safety Data Sheet (MSDS), in accordance with MIL-R-44398, Ration Supplement, Flameless Heater, For Meal, Ready-to-Eat. The MSDS shall be placed inside a clear or translucent plastic sleeve clearly printed in dark, contrasting ink with "MSDS ENCLOSED" and attached to one side of the unit load with pressure -sensitive tape or adhesive.

A copy of the MSDS must be included with the shipping papers and a copy shall also be placed in the vehicle manifest."

All other terms and conditions remain the same.
