**SECTION B - SUPPLIES OR SERVICES AND PRICES OR COSTS**

This amendment is hereby issued to implement the following changes to solicitation SPE3S1-16-Q-0019:

1. Contractor paid USDA AMS Origin end-item inspection is required for all characteristics herein. Alternatively, end-item inspection may be conducted by Public Health Center AVIs present within the contractor's facility.
2. On page 6 of the solicitation replace paragraph 1, sentence 1 with the following text:  
"Item Description: TORTILLAS, SHELF STABLE, bulk pack, 200/2-count packages per case, min **2.1 oz.** flex PG, each count of 50 tortilla packages shall be separated by divider/sleeve made from a firm material such as cardboard in order to prevent packages from shifting.
3. All other terms, conditions, and requirements, of the solicitation shall remain the same.
