MRE ADD ON

- MRE 37 (XXXVII) add-on acquisition
 - Additional 800,000 cases requirement
 - Competition limited to the three MRE contractors
 - AmeriQual
 - Sopakco
 - Wornick
 - Utilizing the Trade-off method
 - Anticipate award by July 2017



PORK-FREE MRE

- ◎ Item is “Case A” of standard MRE NSN (menus 1-12)
 - Is not Halal/Kosher
 - Purpose was to provide an Operational Ration that could transit countries that prohibit pork products
 - NSN (8970-01-623-9560) established March 2014
- ◎ Current award process:
 - Award requires issuing a delivery order against the NSN
 - Modification to reduce the quantity of MREs purchased under regular MRE NSN
 - Need Contractor approval to reduce ordered quantity at no cost

 - 3 Applesauce Types
 - Apple Slices
- ◎ Awarded October 14, 2016 as part of Rations National Contract (RNC)

 - HOT MORE - Long duration/Extreme exertion
 - Min (1 tier) - 3,058 CS, Est (1 tier) - 12,232 CS, Max (all tiers) - 107,030 CS
