

2. Purpose: The Clothing and Textile (C&T) Functional Panel will be responsible for consideration of matters concerning vulnerabilities to fraud that exist in the acquisition of clothing and textiles by the Defense Personnel Support Center (DPSC) to include, organizational structure, policies and procedures, industrial base for manufacture and supply, internal control procedures in the areas of contracting and quality assurance, the impact of small business and disadvantaged business programs, specification requirements and methods, training policy for quality assurance representatives and specialists, inspection procedures, contract management policy and procedures, and criminal investigations.

3. Functions: For all programs under its cognizance, the Clothing and Textile Functional Panel will accomplish all those responsibilities as listed in DLAR 5800.1, paragraph VA2.

4. Membership: The Clothing and Textile Functional Panel shall consist of a Chairperson and members of the DLA staff as designated below:
